6.3.1 Curriculum Development

The College follows the Syllabus and Curriculum of Karnataka University . Every department has its own academic calendar to run and complete the syllabus.

6.3.2 Teaching and Learning

The syllabus is framed by the university to which it is affiliated; each department adopts some innovative processes in teaching and learning.

1. The members of each department meet at the beginning of each academic session for term-wise allocation of syllabus assignments, contents, fix dates for the term-end tests and prepare the academic calendar of that session.

2. The departments organize seminars, quiz contests for the students.

3. Field study and Project work is carried out by the departments of the College.

4. Diversity of Learners in respect to their background, ability and other personal attributes will influence the extent of their learning. The teaching-learning modal of the institution is rendered to be relevant for the learner group. Teachers employ interactive and participatory approach to make the syllabus interesting for them.

iii) Latest books and journals are purchased and subscribed to every year.

iv) Internet service has been made available to the students.
